



ADMISSION PROCEDURES

- The academic session starts from July every year (as per VBU rules)
- Application for admission has to be submitted on the prescribed form obtainable from the Office of the Mahavidyalaya on payment of Rs. 500/- in cash and on Rs. 600/- by post through Bank draft only in favour of the Principal of the institution. Photocopy of Admission Form & Net downloaded copy may be accepted.
- For Admission in Five Year Integrated B.A. LL.B. course

Eligibility - (A candidate for admission in B.A., LL.B. (Hons.) 5 Years course must have; of the age of 20 yrs. for Ge, Category).

Passed the Higher Secondary (10+2) or an equivalent examination securing, not below 45% of the total marks in the case of general category, 40% of the total marks in the case of ST/SC, applicants 42% marks for OBC applicants.

Admission shall be on the basis of marks followed by counselling to be conducted at Jharkhand Vidhi Mahavidyalaya Campus.

2. For admission in Three year LL.B. Course:

Eligibility:-Acandidate for admission in the LL.B. (3 Yr Course) must have:

Graduation degree or its equivalent from any recognized university with a minimum 45% of the total marks in case of general category applicants and 40% in case of ST/SC applicants, 42% marks for OBC applicants, no age limit for Gen. category, SC/ST & OBC applicants.



Mr. A. P. Sharma, Member, Bar Council of India New Delhi Admission shall be on the basis of marks and followed by counseling to be conducted at College Campus.

However such minimum qualifying marks shall not automatically entitle a person to get admission in the institution. It shall only entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the University Government concerned from time to time to apply for admission.

3. Master of Laws (LL.M.) English/Hindi Medium

Objective: The two years Distance Learning Master of Laws (LL.M.) conducted by The Jharkhand Vidhi Mahavidyalaya under Kalinga University, Chhatisgarh, Nagaland has been designed for meeting the demand of the growing needs of experts in the fields of jurisprudence, constitutional history, paralegal services, right to information and specialized laws for women and children, human rights, arbitration, criminology, torts, labour law banking, environment, companies, families, intellectual property rights etc.

Those completing LL.M. degree are preferred for Jobs in the Universities, College and Research Institution, promotions are made based on LL.M. qualification acquired by whose are, in the Judicial services in the Central/State Govt.,/Private & Public Sectors.

Eligibility: Bachelor of Laws (LL.B/B.L.) Bachelor of General/Academic Laws (B.A./B.G.L.) Duration Three Years Award: Master of Laws (LL.M.) shall be awarded to all the successful candidates by the Kalinga University, Chhatisgarh.


Requirements:

Application for admission in LL.M. (Distance Mode), LL.B. 3yrs & 5Yr courses require the following documents.

1. Attested photocopies of original documents of matriculation certificate/ 10+2 or Intermediate or equivalent certificate & mark sheet Graduation Certificate, Admit Card of previous examination.

At the time of admission: LL.M. (Distance Mode), 5Yrs. BA. LL.B. (Hons.) & 3Yrs. LL.B. (Course)

- Five copies of recent passport size color photographs.
- Original documents, of Matriculation Certificate / School leaving certificate / College leaving Certificate I 10+2
 Marksheet/Graduati On Marksheet/Character Certificate.
- Original Migration Certificate (in case of candidates coming from other University or Boards).
- In case of SC/ST/OBC candidates are bound to submit original Caste Certificate/Income Certificate/Residential Certificate.

RULES OF MAHAVIDYALAYA

- (i) Admission cannot be claimed as a matter of right; it may be refused or cancelled if any of the required documents (original) are not produced at the time of admission or if it is found to be false at any time after admission, or the admission is considered as detrimental to the interests of the Mahavidyalaya and University.
- (ii) Employees of any other institution or department (either Private or Government) seeking admission will have to submit written No-objection Certificate from the competent authority of their institution or department at the time of admission.
- (iii) Admission in LL.B. Part 1, 3 year Course of 1st semester will close on 31st July & IInd semester of the year and all applications must reach the Office of the Mahavidyalaya by June 30 or as notified by the Mahavidyalaya.

(iv) Admission in LL.B. Part II or III year of LL.B. 3 year Course may be taken even before the publication of the results of LL.B. I or II year examination, respectively or as notified by the Mahavidyalaya as per provision in V.B. University, Hazaribag.

A. FREE LEGAL AID CLINIC AND HUMAN RIGHTS CELL

The Mahavidyalaya has set up a Legal Aid Clinic and also Human Rights Cell under the Chairmanship or Principal of the Mahavidyalaya for imparting practical training to students as well as rendering legal aid to needy and poor persons of the locality / district. Teachers and advocates have been associated with the Clinic and Cell as members as per guide line of Civil Court, Koderma.

B. CONFERENCE AND SEMINAR:

The college organises seminar at local & national levels or regular basis.

C. IDENTITY CARD:

Every student of the Mahavidyalaya must possess and Identity Card having passport size photograph with full signature of the student and the signature of Principal/Proctor of the Person authorised by the Principal.

D. LIBRARY:

The Mahavidyalaya has an independent library having a large collection of Law books, law reports and journals such as Indian Bar Review A.I.R., S.C.C., Local periodicals and some foreign reports like All England Reporter. Sweet & Maxwell's Journal for the use of students,

teachers and advocates;, Multiple copies of prescribed and recommended readings materials are available for the students. Sitting arrangements are provided for 15% of the students at a time in the reading hall. The library is in the charge of a qualified and trained librarian. It is proposed to Publish a quarterly Law Journal of the Mahavidyalaya in which the students, teachers and advocates may contribute their articles.





*The rules of the library are as follows:

- The library of the Mahavidyalaya remains open between 11A.M. to 3:00 P.M. on all working days. (i)
- Studdents are allowed to use the library only after on presentation of Identity Card to the Prof-in-Charge library or (ii) librarian or any person appointed by the Principal.
- Students desirous of taking library books on loan for reading at their home will have to deposit a sun of Rs. 500/- as (iii) caution money. Books will be issued to them for a maximum period of ten days. Not more than 2 books will be issued at a time.
- In case the books issued are not returned within 15 days, a fine of Rs. 1/- per day per book will be charged. If book is (iv) not returned after the expiry of 20 days from the date of issue, the caution money deposited shall be forfeited and the student with holding the book shall also be liable to pay fine and the current price of the book; further he/she shall not be permitted to use the library facility in future and may also be detained from appearing in the examination.
- If the caution money deposited by the students, refundable subject to the clearance of all dues of the Mahavidyalaya (v) and also of the University, if any.
- Some specified journals and books will not be issued for use outside the library. (iv)

COMMON ROOM: E.

The Mahavidyalaya has a separate common room for boys and girls equipped with indoor games facilities. Students desirous to use room must follow the rules framed by the Prof-in-Charge, of common room.

PLAY GROUND F.

Provision have also been made for a playground and adequate facilities for games and sports under the able guidance of an instructor. Students desirous to use the facilities should contact the Instructor (physical trainor) or person appointed by the Principal to work in his place.

ENQUIRY COUNTER: G.

The Mahavidyalaya has a separate Enquiry Counter from where all imperative informations relating to the Mahavidyalaya/University may be obtained. All necessary forms are available at the counter. Application forms may be deposited at the Counter for which receipt will be issued.

EXAMINATION DEPARTMENT: H.

The Mahavidyalaya has a separate Examination department with Pro-in-Charge of examination. An assistant is available during office hours to provide necessary informations regarding college examination, university examination, registration etc.

CONDITION FOR FILLING UP THE EXAMINATION FORM:

- At Least 75% attendance is compulsory for appearing at the university examination. 1.
- Practical classes shall be held in the court. Attendence in the court is compulsory if failed, the candidate will not be 2. sent up for the university examination.

J. STANDING ORDER:

- (a) Classes will be held in day time as per routine of the Mahavidyalaya.
- (b) The office, however, remains open from 10:30A.M. to 4:30 P.M.
- (c) Notices intended for the students are put up on the Notice Board. A plea of ignorance of any notice will not be accepted as a excuse for failure to comply with it. Students are advised to see Notice Boa -d regularly on all working days of the Mahavidyalaya.

SYSTEM OF EXAMINATION IV.

Examination System:

Each course shall be of 100 marks. For evaluation, the overall structure of the distribution of marks in a theory based course shall be such that 30 marks are alloted to various assessments during the semester, while 70 marks shall be alloted for the end semester examinations. For core, elective and activity based compulsory course, the examination system would be different as per details given under:

Theory Course:

Following scheme of examination shall be applicable for theory course:

- The assessment (sessionals) in theory courses will comprise written assignment (project work), Sessionals: Oral presentation and regularity in each of the course offered by them. (i)
- Such assessment in each course shall carry 30 marks, of which 20 marks will be for written assignment (project) and Oral presentation and 10 marks for performativity, regularity and (ii) alterness in the class pertaining to the concerned course.
- The written assignment(s) and oral presentation shall be submitted by the students to the teachers concerned, by a date fixed by the Head of the Department. (iii)


