- 2. Yes, students coordinator are selected from among the students and their names are sent to the district administration for final approval We have received a letter from the local administration from among the faculty members to function as the coordinator of electoral club, we have appointed Prof. Rakhi Kumari Gupta to function as coordinator and sent his name for final approval. All our employs actively participate in the election process. They sincerely perform their duties assigned by the district administration for the peaceful conduct of election.

- 5. Ours is an HEI where most of the students are above the age of 18. They all have voting rights but most of them have not got their name enrolled in the voter list. To identify such students, though not mandatory, we demand their voter id card at the time of admission and if we find them not enrolled as a voter, we help them in getting registered. We often organize a camp taking the help of local administration and BLO to get voter ID card of our students prepared. The local residents also get themselves registered in such camps. Some get the error in their voter card rectified in these camps. It is a kind of social service to the people of the surrounding.

The continuous internal evaluation (CIE) component includes class tests, tutorials, assignments, class seminars, group discussion etc. Assessment is an integral part of teaching-learning process. With regular interactions of IQAC and Heads of the Department, Examination Committee makes plan for reforms in evaluation system. The college internal evaluation process is decentralized in order to make it more transparent and objective. As per the academic calendar the college prepare tentative schedule and displayed on the notice board, website and on the whatsapp group of the classes. The college adjust academic calendar by including internal assessments, and university examination. The college takes extra efforts for slow and advanced learners and they are assessed by different methods. The examination committee monitors and conducts internal examination in the college. The college has mechanism for transparent and robust internal assessment as below.

• The transparency is maintained by sharing answer sheet with students and the grievances of the students about assessment if any are addressed.

- Class tests semester wise with Multiple Choice question pattern are conducted by the subject departments.
- Question papers are set as per the university examination pattern.
- Students are provided question bank which is maintained in the college library.
- The subject teacher monitors students field work, visit report and project works.
- Oral examination based on practical work is carried out for the assessment.
- The college has various skill oriented certificate courses which are also assessed by the respective subjects.

2.5.2

Mechanism to deal with internal examination related grievances is transparent, time- bound and efficient

Response:

Examination related grievances are handled by the student mentors to make it time bound and transparent. Semester examination answer scripts are distributed to the students as regard to total checking and for clarification if any. The marks awarded for the semester examinations which constitute the internal assessment component are displayed on the departmental notice boards. Student approaches his mentor for the clarifications related to internal marks of tests & others if any. Student issues related to the above will be perceived by the mentor within a time period. Student mentor cross checks the same issue with the department and exam section. Recommendations are forwarded to the department internal committee. A Clear report of the issue will be given to the examination section through the department. The entire process is monitored by the superintendent Examination and then the final details are forwarded to VBU university, Hazaribag. All issues regarding examinations are identified and sorted out for further action. Grievances related to the University external examinations are forwarded to the Examination Controller, VBU university, Hazaribag

Attendance report: Student attendance management system send whatsapp message to students/parents. The attendance report is prepared every month by respective class tutors.

Syllabus & Schedule: The Syllabus of the exam is announced well in advance before the examination. Since detailed question papers are prepared in accordance with University exams, students get the chance to prepare thoroughly covering all the topics. The schedule of the examination is also prepared in advance and given to students. This gives students ample time to study for the examination.

Centrally held Examination: The examinations are held centrally and coordinated by the Examination cell. This minimizes chances for malpractices and emulates the invigilation and seating arrangements of university examinations.

CCTV Surveillance: CCTVs are installed in the examination halls to ensure utmost transparency as per the directions of VBU university, Hazaribag.

2.6 Student Performance and Learning Outcomes

2.6.1

OBE pattern was initially introduced for the UG programmes. As part of the introduction, the faculties were trained to prepare curriculum in line with the characteristics of OBE. In the training, the faculties were oriented to focus on the students' attainment in higher order learning to develop various skills, especially their cognitive thinking. Programme Outcomes (PO) were formulated reflecting the Vision, Mission and Strategies of the College and the UGC guidelines on Graduate Attributes. While formulating POs, the College considered academic excellence, research potency, scope of extension activities, human values, livelihood generation, and recent trends in the job markets. The suggestions of the alumni and other stakeholders were also taken into account. The entire curricula were restructured and the assessment patterns were modified in consultation with experts. The students were enlightened with the PO pattern through the College Website, Digital Board, Handouts and orientation by the concerned course teachers.

The Programme Specific Outcomes (PSO) is designed by the concerned Departments with their respective vision, mission and scope of the programme. The Course Outcomes (CO) is formulated by the Department in consideration with the course teachers and with expected cognitive, affective and psychomotor learning levels. The Course Outcomes are assessed at the completion of each course and the Programme Outcomes are measured at the time of completion of the programme. The College follows the Choice Based Credit System (CBCS) to widen the teaching and learning activities by which students have the flexibility to opt for courses of their choice. The curriculums under CBCS have been strengthened with the introduction of OBE and the courses have been reinforced with desirable outcomes. Evaluation system has been modified to evaluate the courses with respect to the desirable outcomes. OBE helps the learners to achieve higher order learning levels based on Revised Bloom's Taxonomy, master the courses, and develop different skills as expected in each course. Moreover, it inculcates employability and entrepreneurial skills in the students. OBE enriches the courses offered in each programme, equips the teachers with knowledge and skill, and, empowers the learners with attainable outcomes of the programme. It develops the optimistic attitude in the learners towards vertical development in their future endeavours.

The Knowledge and skills described by the course outcomes are mapped to specific problems on University Examination, internal exams and home assignment. Throughout the semester the faculty records the performance of each student on each course outcome. Average attainment in LAW five years course (BA LL.B) all subjects are = University Examination (80%) + Internal Examination (20%). And LL.B Three year's course contains University Examination (70%) + Internal Examination (30%).

Indirect assessment strategies are implanted by embedding them in students' Survey/feedback, and Alumni Survey.

Finally, program outcomes are assessed with above mentioned data and the IQAC Committee concludes the Programme objective attainment level. The following scoring function is used to calculate the average attainment of each Programme objective. According to the above depictions, each Programme objective is assessed and finally, the attainments are found.

Our Library: Our library is partially computerized by automating the issue of books via modified software. The library has about 8000 books covering all major fields of LAW. The library covers an area of 6385 sq. ft. with conference room and an ample study space. Excellent Resources are available for self-learning at library

The main objectives are:

- Members are prone to live together in a cohisive manner to fulfill their every need and aspirations for achieving goals;
- In every society there are various factors that make members deviative form social bonds parallaly, infringing others in alcoholism, matrimonial disputes, property related restlessness, religions disharmony owing to illiteracy and superstition;
- In the concept of intoxication, illicit liqure (Hooch; Impurious liqure) is posing a serious threat to society members due to severe poverty which compel them to consume for lacking of purse'

affordability.

- Unscrupulous businessman, money-lenders, touts and other types of middlemen often represent the fowl aspects of the society in which we can't remain indifferent; for our main responsibility is to maneanvor the society from worse condition to a rectified one because peaceful and tranqulled society is the basic requirement for transforming into a civic society.
- Present day after introduction of liberal Economy, Consumerism has been accelerated into full momentum: as a result of it members of the society are being entrapped into debts for luxurious livelihoods in the name of "easy monthly installment" provision which premiums can be appeared meager, but totalism in month's brings catastrophe-for salaried individuals have to draw a 'finxd' digits wages in their pay-roll; naturally, these guys have to find out another sources (s) of income to cope with the expenses incurred by them;
- In such a condition, several types of social problems have been arising and we, being the law professionals, are to intervene: if be indifferent another social problems like 'Sui-cide' or 'white/Blue collor' incident or crime be increased, making society more vulnerable to Imbalanceness.

Goal

Making the neighboring residents aware about the factors adversely affecting their peaceful sufferance;

Developing proximity of the students from this Institute with the locals, strengthening bonds.

Focusing Institute's social responsibility obligations.

Context

Jhumri- Telaiya, once famously known India-wide through 'Vividh-Bharti' 24 hours popular Bolly-wood Hindi filmy songs broad caster of AIR, as 'Abhrak-Nagari' (Mica-city), where our Institute is situated, really a semi-urban habitation beside the Dalma-Nawadah forest range of North Chhote Nagpur plateau, surrounded with some scatterred habitations mostly populated with illiterate people consisting of superstitious people whom in a simple term called as 'Adivasi' (aborigines) or indigenous people----basically, the most backward area in this state of Jharkhand. The Institute is situated by Sitarampur Jn.(W.B) to D.D.Upadhyaya (Mugal Sarai) Jn. Grand Chord rail-tracks of the Eastern Railway, only 10 mtrs. away and about 1.5 kms from NH-31, the longest national highway, having 17 numbers from Kanyakumari (TN) to Konima (Nagaland), having sanctuaries, reserve forests, country's first 5 years plan's Telaiya Dam, DVC etc, imaginary 230 30' Tropic of Cancer passage, line at Charhi, famous rebels Birsa-Munda, turmoiling melting pot of resurrections against the Britishers, mythical Pilgrimages of vaidyanath, vasukinath, Bhadrakali, Chhinn-Mastika, the richest minerals reserves-state in India-all great credentials does have under possessions with this Jharkhand, but it's a tragedy that locals are there where they had been-as their ancestors used to be----- only those who have reached from other states whom the 'Adivaris' termed as 'Diku' (Plunderers from outsides): problems today we are facing about intoxications, crimes, extra marital affairs and related murders, extortions, human trafficking, spurious liqure productions and pilferages, jungle deforestation with Inter-States mafia linkage---the law students use to conduct legal aid programme for awarenss. Result is that in initial days of the Institute's establishement, there had been crimies regular mode; but today its has been minimized and in real fact is 'Zeroed'. All the corrections have been possible due to continuous awareness drive

- During corona pandemic, when no physical attendance was possible; the residents of college premises with the support of Management relief packets of food grains, vegetables, edible oils, clothings etc. had been distributed on regular intervals.
- Locals, taken in association with students brigade under supervisor-ship of Mrs. R.K. Gupta, Mr. R.P.Dutt, Miss. Kumari Suman, conduction of awareness drives have been conducted for years.

Evidence of success

- It is evident that students' relentless efforts have created massive change in the locality like women, especially, wives and girls who are easy victims of alcoholism have been zeroed which had been a regular menace after sundown only a few years back.
- Today, the locals who usually kept a safe distance a few years ago from the Institute and members, now remain eagerly awaiting when our students brigade would reach! Every alternative Saturday the awareness drive conducted----- now-a days, even in mid-week phone calls come for legal support.
